CMAS, or California Multiple Award Schedule, are contracts between particular vendors and the California State government. The California State government awards the contracts to multiple vendors that provide similar products at similar costs. The contracts are competitively bid and vendors generally apply for the CMAS program with a pre-existing competitively assessed contract. If accepted, the state of California will remove the terms and conditions relating to buyers or other government agencies from the previous contract and insert its own. CMAS buyers must purchase goods through the DGS eProcurement process and school and libraries looking to buy IT services must do so through the eRate program.
